#### PROFESSIONAL RIGHTS AND RESPONSIBILITIES

Catholic Health Partners was scheduled to take over Kaiser earlier this month. They do not plan to make any changes in coverage at this time. However, beginning with the Open Enrollment period on November 1<sup>st</sup>, you may choose to switch to Anthem. Also, if you stay with Catholic Health Partners now, you could still change later if they change their coverage plans significantly.

Open Enrollment is also the time when a member may decide to participate in the Flexible Spending program. Money saved on taxes is just one benefit. The Flex plan serves as a medical savings account, and helps a family budget when there is an unexpected medical bill. It also can be used to pay for child care with tax-free dollars. Contact Sue Garber (after November 1) to sign up for Flex and to notify her of any changes in your family insurance situation from the previous year. Section 20.05 of the contract (see below) allows for up to 10 sick days to be used by a new parent. Using additional sick days does require a doctor's note concerning the health of the mother and/or the baby. Without this note, additional days off are considered unpaid days by the administration.

"b. Pregnancy and Delivery Support Leave An employee whose spouse or qualified domestic partner is pregnant may use available sick leave for up to two (2) weeks at the time of confinement and delivery."

Article XXI (Protection of Teachers and Students) includes the following line: "It is the intention of the administration to support teachers' efforts in maintaining orderly classrooms and in protecting them from unruly students." If any member does not feel safe or is concerned about the safety of other students, they should go to their head-building representative and schedule a meeting with the building principal to address their concerns. While a team-oriented approach is recommended, it is ultimately the administration's responsibility to provide our members with a safe teaching environment free from bullying and intimidation.

#### LEGISLATIVE COMMITTEE

In the wake of the government shutdown, it is important for all of us to stay current on the voting records of our elected officials. The 2014 elections are a year away, but most candidates have their campaigns out in full force. As our elected officials make the rounds in the community, it is essential that we challenge them to preserve the rights and issues that advance public education. Ohio Federation of Teachers has a nice spreadsheet which records each state level congress member's vote on bills passed in the current session. For instance, you can view how Capri Cafaro voted for House Bill 153, which cut \$3 million dollars from public education. You can access the Ohio Senate voting scorecard at <a href="http://oh.aft.org/files/senate\_scorecard\_2012.pdf">http://oh.aft.org/files/senate\_scorecard\_2012.pdf</a> and the Ohio House of Representatives voting scorecard at <a href="http://oh.aft.org/files/house\_scorecard\_2012.pdf">http://oh.aft.org/files/house\_scorecard\_2012.pdf</a>.

Legislation, such as HB 153, directly impacts our ability to teach by blocking teacher's access to Ohio Achievement Assessment data and, thus, limits our ability to properly prepare our students for the tests.

Plunderbund, the online magazine, published a recent article titled, *Ohio's Republican-passed law impedes teacher improvement and student learning*, condemning this legislation stating, "Since 2011, the invaluable test materials and item analysis reports have not been released due to Ohio House Bill 153...In fact, HB 153 was the same bill that implemented the very teacher evaluation system that, supposedly, was designed to improve teaching and learning in Ohio" (October 12, 2013). Education legislation must have the student's best interest at heart and must be grounded in research-based instruction practices. The voices of experienced teachers in the field need to be raised above the din of the current destructive initiatives created by HB 153.

### **Teacher Wins Grants for Program on KSU Shootings**

High School English teacher and SHTA President **John Morris** has been awarded two grants that will allow him to bring a workshop he developed at Shaker Heights High School to a wider audience of students throughout the Cleveland area. The workshop involves staging and discussion of the David Hassler play, *May 4th Voices: Kent State 1970*, about the tragic events that unfolded when National Guardsmen fired upon Kent State University students protesting U.S. involvement in the Vietnam War, leaving four students dead.

Morris received a grant from the Martha Holden Jennings Foundation's Grants-to-Educators Program, which provides support to projects that exhibit excellent teaching and require deep learning. Morris also received the Margot Stern Strom Innovation Grant from the Facing History and Ourselves Program, which stresses the importance of instilling intellectual vigor and curiosity along with facts and figures.

The play investigates different voices and viewpoints from this turbulent moment in American history, examining the roles of both bystanders and upstanders, as well as their place in the history of social protest in the United States.

The workshops will be presented in American history, literature, and theater courses for students throughout Northeast Ohio in spring 2014, as well as to the wider community

#### Dear Colleagues:

I am writing on behalf of the tutors in the Shaker Heights City School district. Although our district designates us as "tutors" we are all certified teachers with teaching responsibilities in our buildings.

There are a variety of tutors who teach in our district. Some of us teach Reading Skills and must obtain reading endorsements, as all teachers of Reading in Ohio must. Some of us are ELL teachers who teach English language learners and must be evaluated based on Student Learning Objectives (SLO's) as other teachers in the district are. Others are Intervention Specialists, who may have the same teaching caseload as Intervention Specialist Teachers, with the same background and degrees, yet are classified and paid as tutors. Our roles and responsibilities have grown significantly this past decade, and we are recognized as teachers both under state law and by other school districts and unions in the area.

We are asking to join the collective bargaining unit as we are currently excluded in the recognition clause of the SHTA contract. In addition, we are paid using a salary schedule that at its highest point does not match Step 1 of the Teacher's salary schedule. Our contracts are year to year and we have no ability to obtain continuing contract status, negotiate for equitable pay, or obtain the benefits of collective bargaining. We work side by side with our teacher colleagues, who may not be aware of these inequities. We have been voiceless and we have not had a seat at the negotiating table in this district. We ask for your support in the upcoming months as we work to obtain inclusion in the district's teachers' union.

Thank you for your fair consideration of this issue and I thank the Shaker Heights Teacher's Association leadership for allowing me to submit this letter.
