# Message From the President

In Our Last Newsletter, I wrote about the necessity we have as an Association to reach beyond our comfort zones into the area of advocacy. The events of the last month and even the last few days have emphasized this reality. Just last week, the story broke of Governor Kasich's proposal in the new budget that teachers must complete an internship with a community business or Chamber of Commerce in order to renew their licensure. Last week, Betsy DeVos, perhaps the most unqualified Secretary of Education since the post's inception, was confirmed by Senator Portman contrary to the phone calls, emails, letters, and inperson pleas by thousands of his constituents to "vote no" on her confirmation. The battle to protect public education is at our doorstep and we have no choice but to fight for our students, our community, ourselves and our profession.

This being said, we have a tool at our disposal to enter into this fight. We may not be able to endorse specific political candidates per Our Constitution and By-Laws, but we can advocate for political issues that impact education at home and abroad. We have a *Political Action Committee*, chaired by our own Eileen Sweeney. We have made pleas for increased membership in the past, and I would like to encourage you to join today by emailing Eileen Sweeney (<u>sweeney\_e@shaker.org</u>) and expressing your willingness to participate as a letter writer, a marcher, or a fundraiser and beyond.

Speaking of fundraising, I am announcing a new fund drive for the PAC in this newsletter. I am asking you to either write a check to Shaker Heights Teachers' Association with "PAC" in the memo line and send it in an envelope to Bill Scanlon at the High School, or to donate using our *GoFundMe* page for the PAC. No amount is too small. Even \$5 would help. We will use these resources to buy materials for letter writing (including postage), charter buses to Columbus (when the opportunities arise), and endow a "Friend of Education" Award sponsored by the PAC. Now is the time to join. Now is the time to make our voices heard. If the past month is any indicator, it's going to be a long four-year fight to defend public education.

Otherwise, it's been a typically eventful month. I helped a member with a benefits issue. I assisted a member with a student disciplinary issue. I also assisted a member with a parent issue. I attended the Insurance Committee Meeting. I updated the Facebook pages for SHTA and the Cuyahoga County Educator Summit (CCES). I had my weekly conversations with Dr. Hutchings and regularly communicated with Darlene Bushley. I attended the session of Professional Learning for Instructional Leaders (PLIL) with observational rounds at Woodbury and Lomond. I emailed members concerning education issues. I attended the "No on DeVos" Rally downtown, alongside other SHTA Members. I worked on a Memorandum of Understanding (MOU) on the Curriculum and Instruction Leadership Council (CILC) Initiative with Terry Breeden. I contacted Steve Wilkins about the water leak at the Middle School and contact time. I attended the CCES Steering Committee Meeting on Thursday, February 9th. I addressed a transfer request. I addressed a schedule request. I conferred on testing schedules. I also conferred on a building and medical issue.

As a special thank you, I would like to acknowledge Dr. Hutchings and Board Member and Legislative Liaison Annette Sutherland for their advocacy and support. Dr. Hutchings and Mrs. Sutherland co-authored a letter encouraging Senator Rob Portman to vote "No" on the Betsy DeVos confirmation. Their letter was reasoned, balanced, and gave cogent arguments for why Ms. DeVos would not be the best choice for Secretary of Education. Unfortunately, we now know the result. However, Dr. Hutchings and Mrs. Sutherland's support for public education and educators means the world to us.

We have entered new terrain with the present administration in Washington, D.C. and emboldened state legislature We have a lot of work to do. #### **POLICY COMMITTEE**

Last month I referred to By-Law VII section D of our constitution referring to Political Donations and expenditures. I would like to highlight a portion of that By-Law this month:

2. The Association will sponsor a Political Action Committee (a special committee appointed by the president) whose purpose will be to support political issues relevant to the Purposes of the Association. Representative Council may direct the building representatives to solicit voluntary monetary contributions from the membership for the PAC. All contributions will be sent to the Treasurer, who will deposit these funds into an account kept specifically for this purpose, and will then forward the funds according to the directive of the PAC. No funds from the PAC treasury shall be used directly for the purpose of donations to elected officials or candidates seeking office.

Our PAC actively looks for ways to support political causes that will improve public education or result in a stable and efficacious teaching environment. It is a challenging time politically for those of us that support public education or believe in the right to collectively bargain. This is the time to support the issues important to us and defend it for those who will follow. Our voices wont be heard without action. #### **LEGISLATIVE COMMITTEE**

Here we go again....the Ohio House Republicans have proposed another version of SB5. On February 14, 2017, Rep. John Becker, of Union Township in Clermont County, sent unions across the state a bitter Valentine by introducing House Bill 53, a version of "right to work" laws. This proposal would significantly restrict collective bargaining groups (unions) in Ohio. Further, buried deep in the state budget (House Bill 49) proposed by Gov. Kasich is a requirement that, as part of the teacher license renewal, all teachers must complete on site work experience with a local business or chamber of commerce. The rationale behind this proposed law is very concerning. Implied in HB 49 is the sick belief that the work of a teacher is not truly "real" work. This is all just more ignorance, arrogance and condescension.

The elections did not only result in ushering a federal administration that is adversarial towards public education and teachers, but republicans have seized total control of the state governments. What makes this so concerning is the fact that these state governments are collaborating on their agendas for the coming year. Included in their short list of "To Do's" is an effort to restrict the power of labor unions and to make changes to public education policies and public pensions. Their imperative has urgency. The state governments intend to move quickly. Legislative issues are heating up with the Trump administration. The appointment of Betsy DeVos as Education Secretary means the advancement of her agenda to expand charter schools. It is particularly concerning that a candidate with such little experience has been advanced to such a high position. Her lack of understanding of IDEA threatens the most vulnerable of our students. DeVos is unaware as to the meaning of value-added. More than ever, teachers must advocate for their students.

This all leads to one conclusion. We must take the responsibility to act to fight. The Political Action Committee needs members to step up and join. The PAC will meet only when necessary and will work on advocating positions on policies impacting education and our students. #### THE EDUCATIONAL-INDUSTRIAL COMPLEX

This newsletter is a publication of the Shaker Heights Teachers' Association, an independent organization of professional educators in the Shaker Heights City School District. Signed editorials represent the opinion of the author(s) and may or may not reflect the thinking of other officers or members of the Shaker Heights Teachers' Association. Members and friends of the Association are invited and encouraged to express their opinions or share information via this newsletter.

On January 17, 1961, then President Eisenhower gave his Farewell Address to the nation in which he famously warned the nation of the growing "military-industrial complex." In this speech he warned, "The potential for the disastrous rise of misplaced power exists and will persist. WE MUST NEVER let the weight of this combination endanger our liberties or our democratic process [sic]." He was right to fear the connection between corporate interests and the national government. The build up of a permanent armament industry was new in the 1950s but has since grown into a trillion dollar per year industry with heavy influence over state and national legislative and executive branches. It cost over \$17,000 to outfit a single army personnel and every corporation salivates on getting their hands on these contracts. Our yearly defense budget exceeds the combined military budgets of next top seven countries combined.

With the selection of Betsy DeVos as Secretary of Education and our current President calling for increased funding of charter schools and voucher systems paid through tax dollars, it is now time to warn of the growing Educational Industrial Complex. Both Republican and Democrats have called for vast changes in educational policy, suggesting that market reforms would alleviate our supposed problems of public schools. From *No Child Left Behind* to *Every Student Succeed Act*, our Congress has created legislation that rewards those that do well on standardized tests (typically upper-middle class, all white suburban districts), forced districts to file endless paperwork, allowed for the vast creation of Charter schools and chastised schools that fail on standardized test scores.

With these market reforms have come plenty of opportunities for corporations to begin extracting more of our tax dollars for programs, tests, charters and other items, which have shown little improvement in our students' progress. Pearson Corporation is the most egregious of these businesses, making huge sums of money to create standardized tests, grade them, creating teacher evaluations, making ever larger textbooks that fail to engage and many more products. But they are far from the only corporate vampires that have sucking our students' blood.

During the 2015-2016 school year, Shaker Heights City Schools lost \$1,006,190 to charter schools and vouchers. Many districts with a higher percentage of poverty lost much more, siphoning much needed resources from our nations neediest children. Every district in Cuyahoga County has lost funding.

What may be even more horrifying is the amount of tax dollars spent on standardized tests. The tests are created by corporations, are accessed by computers purchased from corporations, and are graded by corporations. We have outsourced assessment without examining the consequences; disconnection between students and teachers and the curriculum, students unable to graduate because of test scores, test results returned months after tests are taken making them meaningless towards instruction, etc....

Even our children's' food has been outsourced to corporations. When our cafeteria staff was replaced by AVI, they were forced to reapply for their jobs and received less compensation for their work with our students. Has the quality of food increased? Has the obesity rate changed in our schools changed? Are students eating more nutritious meals to fuel their studies? To my perception, this has not been the case.

All this change has occurred gradually in my tenure as a teacher. In a brief seventeen years we have changed from an institution that is meant to teach future citizens of an ever-changing country and world, to a

market model of creating future workers for high tech fields. We talk of students as "our customers" not as our children. Teachers are chastised by politicians for not preparing our students for the 21<sup>st</sup> century work force, yet they force us to spend endless hours preparing for and proctoring endless tests. Governor John Kasich has suggested that unelected businessmen be placed on all school boards to guide curriculum! The cycle of blame has kept the corporations at the fore front of the debate and teachers far from the conversation. As corporations, their bottom line is to increase their profit. As teachers, we just wish to teach our children.
