President's End-of-the-Year Report

As you all know, this has been a busy year. When the school year started, Ted Strickland was still Governor and there was not even a glimmer of SB5 or HB153. What a difference nine months have made! As SHTA president, I have tried to encourage members to get involved in the issues we are facing while also maintaining the neutrality imposed by the By-Laws. Do you want our Association to permit some political action? Or would you rather the Association stay

separate from politics? It is imperative that you vote in the May 23rd election to decide this issue.

One of the most important tasks that I perform as president is responding to membership concerns and issues. Each situation is important to the individual member. Assisting colleagues when they have a question—about a leave, or steps, or evaluation, etc.—is a serious responsibility and I have tried to provide each member with my best efforts. Attending meetings is another key part of the presidency. Executive Board, Representative Council, Board of Education, Calendar Committee, and Evaluation Committee meetings, for a start; and there is the start-of-school facilities tour and meetings with new teachers and their mentors. There are social events, like the Night for the Red and White and the christening of the boat we sponsored for the women's crew.

As president, I have regular meetings/consultations with members of the Administration. Often we discuss situations that could be problematic for our membership—sometimes exploring alternative actions within the context of the contract. Remember, the contract is an agreement between the Board/Administration and the SHTA—it represents the interests of management and labor. PROFESSIONAL RIGHTS AND RESPONSIBILITIES

I have thoroughly enjoyed serving the Association this past year as Professional Rights and Responsibilities chairperson. We did not file any grievances, but I did work with several members individually on a variety of contractual matters. Most of these situations were related to absence and leave, evaluation procedures, and letters of reprimand. I really appreciate the professionalism from members when I communicated with them by phone or e-mail. Working on the Negotiations team was a valuable learning experience. It was gratifying to see the contract approved last month by the members.

When Senate Bill 5 was introduced in February, I worked closely with Becky Thomas, John Morris and the rest of the Executive Board to decide the most appropriate ways our Association could stand up for collective bargaining rights. The creation of the PAC for Shaker Educators and the work that Eileen Sweeney and John Sweeney have done to make our voices heard is truly an inspiration. I am confident Senate Bill 5 will be overturned by the voters in November, but it will not be easy. Campaign organizers are suggesting individual donations to the Ohio Democratic Party (http://ohiodems.org/) and the We Are Ohio umbrella organization (https://wfc2.wiredforchange.com/o/8808/donate_page/contribute) will be critical to both getting the referendum on the ballot and saving collective bargaining in November. I strongly encourage everyone reading this to donate at least \$10 to each of the groups listed above. If you are not comfortable donating to a political party, donate \$20 to We Are Ohio. If you have

signed a petition, you can imagine the cost of printing these all across the state. In addition, the campaign will have to match supporters of SB 5 in an intense media campaign later this summer and throughout the fall.

With public education under attack at the national, state, and local levels, I strongly encourage you to vote for the amendment to the by-laws that would allow SHTA to provide support for the PAC for Shaker Educators. The PAC would remain a separate entity. No dues money would go to the PAC. Contributions to the PAC would be strictly voluntary. PAC money would simply be handled by the SHTA treasurer, which would make the PAC both more efficient and more accountable to its donors. I envision a day when the PAC is endorsing teacher friendly candidates for School Board, the state legislature, even Congress. The PAC needs our support to be able to accomplish its goals, especially in the current climate.

We must stay vigilant, even as we take time to enjoy the summer.

TREASURER'S REPORT

On Monday, May 9, 2011 at the Representative Council Meeting I presented the budget for the 2011-12 fiscal year. Representative Council Members approved the budget for placing it on the May 23rd ballot.

On Thursday, May 12th I and the rest of the Investments Committee (Darcel Arrington, Todd Keitlen, Matt Zucca, and Dollye Finney) are meeting with Brady Krebs, our Edward Jones advisor to discuss our investments and look at any possible changes.

This week I signed our Form 990 (tax form) and sent it off to the IRS. It was not late – we applied for and were given an extension.

We received our compilation financial statements from Edward C. Hawkins & Co., Ltd. If anyone would like to peruse them, just contact me.

The current financial report is included.

Some of the activities I performed while fulfilling my duties as Treasurer this year are listed below:

- I attended Executive Board Meetings and Representative Council Meetings throughout the year.
- I maintained our insurance through Musgrave Insurance.
- I met with the Investments Committee and Brady Krebs, our Edward Jones advisor, twice this year, once in the Fall and once in the Spring to evaluate our Edward Jones investments and make changes that were deemed necessary.
- I met with the Investments Committee at other times throughout the year to discuss other options for our Association investments.
- I met with our accountants at Edward Hawkins & Co. to prepare the books for the compilation of our 2009-10 financial records. I also met with them to complete the paperwork for our Form 990 tax filing.
- I managed our Certificates of Deposit and our bank accounts.
- I closed our account with Buckeye State Credit Union transferring the \$66,000 into our Key Bank Account.
- I communicated with the Shaker Heights Board Office to pay the salaries of our six paid Officers and Committee Heads, along with the relevant STRS and Medicare payments.

- I paid the members of the Negotiations Committee a salary for their work negotiating our current contract.
- I paid the S.H.T.A. Representatives their compensation for attending the meetings throughout the year.
- I prepared the 2011-12 fiscal year budget for approval by the Representative Council at the May Association meeting.
- I paid bills throughout the year and balanced the checkbook, reimbursing any Association expenses incurred by our members.
- I initiated transfers between line items of the budget to maintain positive balances in each spending area.
- I kept accurate record of our finances throughout the year, maintaining a paper record of every transaction.
- I met with and discussed Association business with the other Officers and Executive Board members throughout the year when needed.
- I attended 3 anti-SB5 rallies (2 in Columbus, 1 in Northeast Ohio) and worked with the organizing team for our own Shaker rally. I also worked to get petitions signed for the referendum on the law.

This has been a tumultuous year politically for us teachers. It is vital that we have a voice in educational decisions made by state policies. I want to encourage everyone to **vote for the by-law change** on Monday, May 23rd. Our association will benefit from being permitted to link itself to the political work being performed by its members.

It is also vital that each and every member continue fighting SB5. Why not do your part? Come to one of the trainings. Get a petition. Take it to your social events and get friends to sign. I spent the past two evenings at the Woodbury band concerts collecting signatures and making people more aware of this issue. I had a number of people thank me for giving them the opportunity to sign. This petition signing is just the beginning. It is going to be a long summer, with many political arguments going on for and against the new law. We are currently shielded from its effects because of our 3 year contract (Thank you to the members of the negotiating team.), but if we don't get it repealed our lives will change drastically in 2014. Stay vigilant.

Lastly I would like to say thank you to Becky Thomas. This has not been an easy year to be the S.H.T.A. President, but Becky has kept her spirits up and stayed positive throughout it all. We have all benefited from her hard work.

LEGISLATIVE COMMITTEE

Legislative Report: Keep your eye on HB 153

While teachers and other public employees statewide are mobilizing efforts to see SB 5 go to referendum, do not forget about House Bill 153, the Kasich budget bill that I mentioned in last month's newsletter. HB 153 deserves the same amount of attention on the part of teachers as SB 5 does, because it contains a lot of the same measures. Even if SB 5 is voted down in a November referendum vote, some of its key measures could slip into place via a passage of HB 153.

HB 153 outlines the merit pay and teacher evaluation issues. Instead of districts relying on steps, they would be mandated to base teacher salaries on the following criteria:

- *Licensure level
- *Whether a teacher is considered highly qualified
- *Annual observations: two 30-minute observations annually and parent/student surveys figure into the observation piece

Not only will the above criteria determine teacher pay, but will also impact a teacher's job security. Under the HB 153 model, teachers will be labeled as one of the following:

- *Highly effective
- *Effective
- *Needs improvement
- *Unsatisfactory

Teachers who consistently score as needing improvement or as being unsatisfactory would most likely lose their jobs, and would definitely lose their continuing contracts (if hired before 2011; all hired after that date would no longer receive continuing contracts). Please be as dedicated and vigilant in your opposition to HB 153 as you have been to SB 5. Please contact your representatives, make phone calls, write letters, do whatever it takes to make your voice heard.

This is a frightening and unsettling time for the teaching profession. We have seen our reputations and our professionalism attacked like never before. While it has been an opportunity for many to finally speak up and be counted, we are, and will continue to be, under threat of losing public favor, job security and income. While it has been a pleasure and a burden to report the current happenings to you, I encourage each and every one of you to remain informed and involved. The legislation that is afoot and the lawmakers behind it could directly impact each of us in profound ways. These are not someone else's problems, they are yours.

Do what you can, be well, enjoy the summer, and hope for better days.

SECRETARY'S REPORT

MINUTES FOR THE REPRESENTATIVE COUNCIL MEETING May 9, 2011 Onaway School

Rebecca Thomas, SHTA President, called the meeting to order at 4:30 p.m.

Stay Vigilant.

I would like to say that this is the end of another great year as a public educator. That would be a lie. It has been the most difficult in my 14 years of teaching. We are in an all out war against public teachers in Ohio being waged and led by our governor John Kasich. Whether it is the frontal assault of SB5 against teacher's collective bargaining rights, seniority protection and pay or HB153 and its efforts to pass many of the same measures through the budget; it's been a very tough year to be a teacher. And it's happening nationally. Look at Wisconsin, Indiana, Michigan and New Jersey and the onslaught of legislation and cuts against public school teachers and public employees orchestrated by political forces that want to see unions silenced in this country forever. I am proud to say that I am part of the effort to reverse these trends and ensure that we have a voice at local, state and national levels. We all have to continue to be a part of this effort.

It's time for us to stay vigilant, a theme you may have noticed in many of this issue's columns. I applaud all of our members who have stood up to attend the April 14th rally, volunteered for referendum training, collected signatures and signed petitions. But our work is far from done. The Kasich administration is depending on us being dormant as the summer arrives. We can't afford that. I applaud the effort on the part of the OEA to collect \$54 per member to create a \$5 million dollar publicity fund to fight against SB5, get the referendum on the ballot and vote this legislature down (1). I believe we are going to see a very well-funded effort on the side of the Kasich camp to promote SB5. In fact, just this week, Kasich advocates launched One Ohio United as an answer to We Are Ohio, claiming that their organization is not supporting SB5, just the budget (2). The subtext is clear and this is just the beginning. I believe that everyone from the Koch Brothers to the CEO of White Hat Schools will contribute heavily to advertisements and websites that promote the virtues of SB5. That's why it is so important that we vote to amend our constitution and by-laws on May 23rd in order to make contributions to the PAC of Shaker Educators. We need to have a high voter turnout – it takes the approval of 75% of the membership to make this happen. We might not be able to generate \$5 million

dollars, but anything helps as we attempt to travel, create literature, and make contributions to campaigns such as We Are Ohio and others.

Likewise, we have to look beyond divisions and see the big picture. Becky Thomas and I met with Bill Lavezzi, executive director of the NEOEA, and he said, "If we focus too much on our past, we won't have a future." In other words, whether the opportunity is to work with the OEA or the OFT, Steelworkers, or Teamsters, SEIU or AFSCME, we have to chip in where and with whomever we can to fight this poisonous legislation. If we don't and the SB5 referendum fails, we will be, for all intents and purposes, a "right to work" state. We will be unionized workers, all of us, in name only.

It hasn't been a good year to be a public school teacher. But it has been a good year to realize how much I value my Association and my colleagues. I believe we have an extraordinary group of teaching professionals and labor advocates in the SHTA. Now we have to keep our nose to the grind stone this summer. We can't afford to escape into a good book, or a new program, or continuing education alone. We have to keep our eyes on defeating SB5 so we can continue to have an Association, a school district, a state and a profession to which we have invested so much of our ideals, time, and lives. Stay vigilant. The fight has just begun. JM
